Extended Submission Period

From **February 10-March 24, 2010** (inclusive) the [submission period for applications](#) is increased from 15 to **25 days** for:

- New applicants who are applying to operate a taxi or limousine in any part of the Greater Vancouver Regional District or the Squamish-Lillooet Regional District
- Taxi or limousine licensees who are applying to transfer or amend their licence or add vehicles to their fleet and who operate in any parts of the Greater Vancouver Regional District or the Squamish-Lillooet Regional District

For all other applications, the submission period remains the same.
