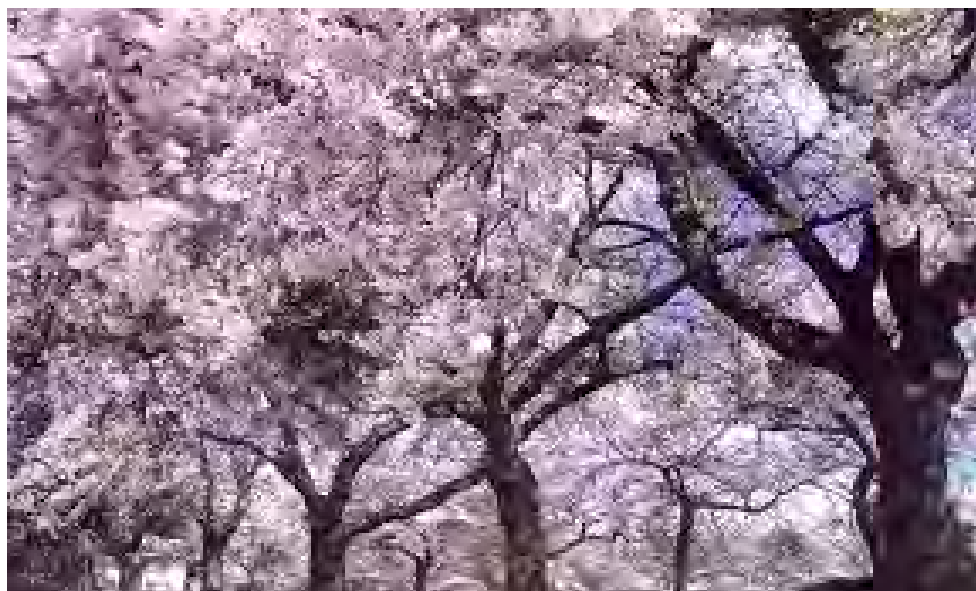


# Passenger Transportation Board Weekly Bulletin

### YVR Zone Boundary Map & Rule

The Board is amending its rule for taxi rates in the Lower Mainland to make minor changes to the map for YVR zone rates. Effective March 1, 2016, changes enhance the labelling for boundaries of several zones in downtown Vancouver. Boundaries and rates remain unchanged.
