

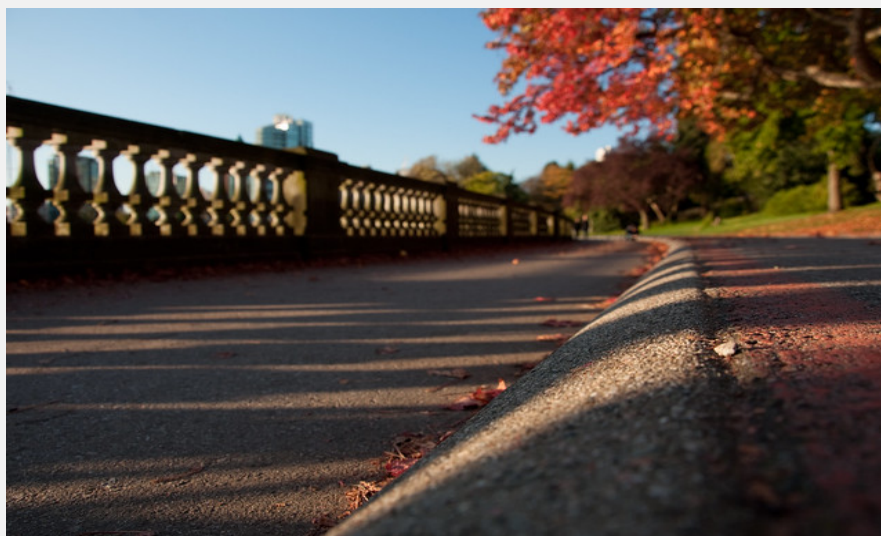

# 1 Industry Updates & Advisories

## App Requirements for Taxis, Limo & Other PDVAs

## Comment Period for Ride-Hail (TNS) Applications Extended

The Passenger Transportation Board received a request for an extension on the standard 10 day review period for public submissions on TNS applications from one interested party. In the interest of fairness, the deadline has been extended for all interested parties from 10 days to 15 days on all TNS applications received to date.
