

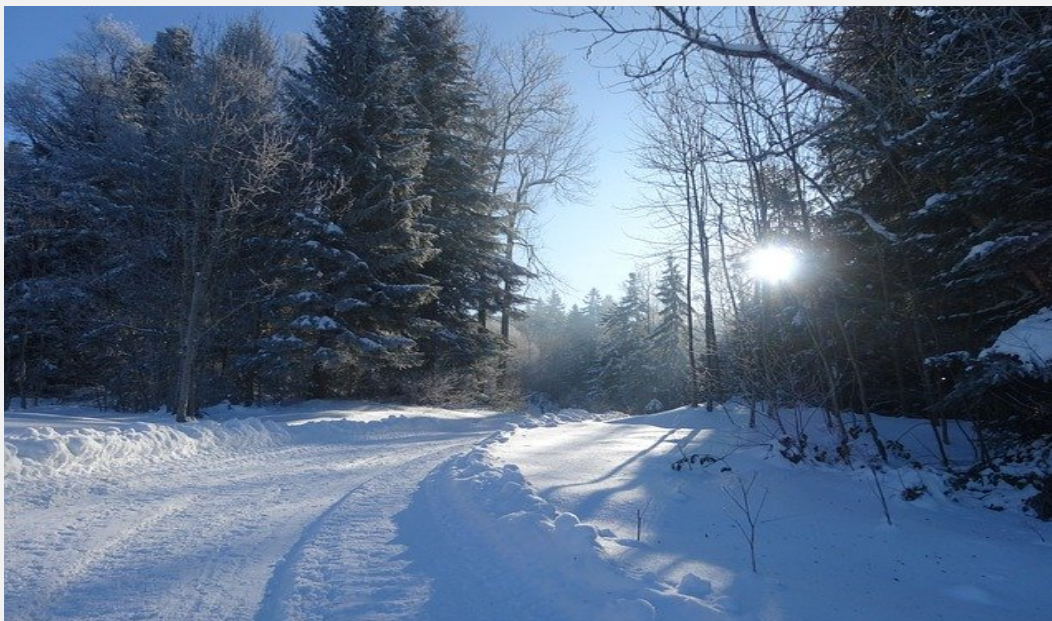
## Passenger Transportation Board

# 1 Industry Updates & Advisories

## **Board Modifies Process for Ride-Hail Applications**

Board modifications to its ride-hail (TNS) application process enable submitters to review and comment to the Board on applicant responses to original submissions, as well as the application package itself. See [Industry Advisory of October 30, 2019](#).

## **App Requirements for Taxis, Limo & Other PDVAs**

The Board updated apps requirements for taxis, limousines and other licensees with a Passenger Directed Vehicle Authorization. Requirements are posted on the [apps webpage](#) and take effect September 25, 2019.
