Festive Season TOPs for Taxis

For the 2020 'festive season', taxi companies in BC may apply for Festive Season Temporary Operating Permits (FSTOPs) and choose any time period from November 15, 2020 up to and including January 15, 2021. To apply, see section 2 of [Refence Sheet 17 \(TOPs\)](#).

Peak Season TOPs for Limousine- Festive Season

Peak Season Temporary Operating Permits (PS TOPs) enables limousine operators to meet cyclical demands or season demands when additional vehicles are needed on a temporary urgent basis. To apply, see section 3 of [Refence Sheet 17 \(TOPs\)](#).
