

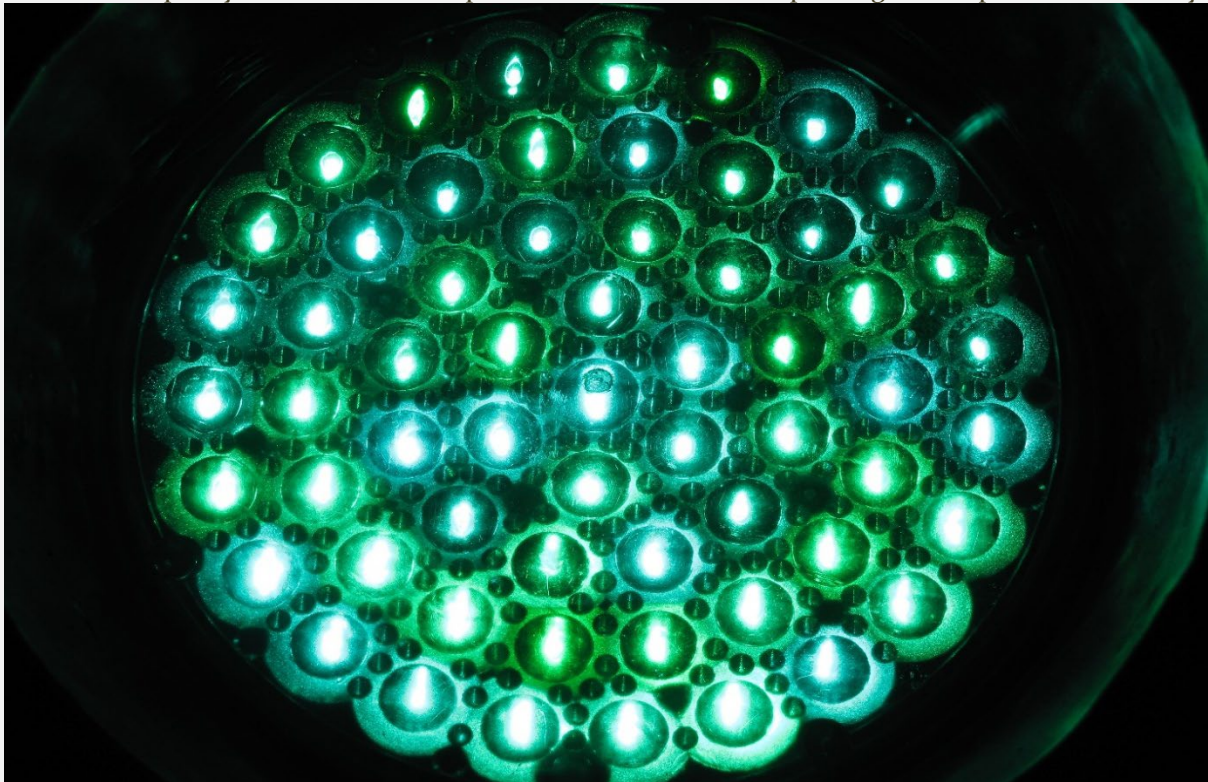

## 1 Industry Updates & Advisories

### **Final Deadline to Activate Additional Taxis**

The Board is issuing a final activation deadline of December 31, 2022. Licensees will have until this date to activate additional vehicles, or they will no longer be valid.

### **Vancouver Cruise Ship Schedule for TNS and Taxi Operators**

### **TOPs Processing Reminder**

As summer gradually winds down, licensees planning to apply for a Temporary Operating Permit (TOP) should do so well in advance and not wait until the day before or the day of the requested TOP start date.
