

I. Background

- On March 17, 2022 the Board approved a Taxi & Limousine Cost Index (TLCI) 2022 rule that permits a rate increase of up to 5.3% for licensed taxi operators in British Columbia.
- The Board uses the TLCI as an objective basis for periodic reviews of taxi rates, and TLCI 2022 is based on an increase of 5.3% in the Consumer Price Index (CPI) for BC. Details are posted at <https://www.ptboard.bc.ca/tlci.htm>.

II. Rates for Taxicab Companies

The following rates and taxi meter formula must be implemented on **May 1, 2022**:

Type of Rates	Rates (without tax)	Rates (with tax)	Rounded Rates (with tax)	Taxi Meter Formula (with 5% GST included)
Flag	\$3.4243	\$3.5955	\$3.60	\$3.60 for the first 47.82 metres
Distance (per km)	1.9916	2.0912	\$2.09	\$0.10 for each additional 47.82 metres
Wait Time (per hour)	42.9040	45.0492	\$45.05	\$0.10 for each consecutive 7.99 seconds

III. Applicable Licensees

This Board Rule applies to all Capital Regional District (CRD) taxi operators. See Appendix A for a list of CRD taxi operators. The list is subject to change.

Start of New Rates: **May 1, 2022**

Date of Rule: March 17, 2022

V. Other Rules

1. The Board's "Standard Rules for Taxicab Rates" effective November 16, 2016, as amended from time to time, are in effect and applicable to licensees listed in Appendix A.
2. The "Board Rule Respecting CRD Taxicab Rates" effective July 27, 2019, is rescinded.
